

I will continue to be looking at ways we can gather and still be safe. At this time, I do not know when our meeting room will be made available. If you have any suggestions for what we can do, please let me know and we will explore the possibilities.

Merry Christmas and Happy New Year 2021. Hopefully with the vaccine becoming available we will see some better times ahead.

Sunday December 13, 2020

Our East Valley Model-T Club had to wait for nearly a year before we could all get together for a meeting and ice cream gathering, but we were rewarded with a banner turnout of 47 members and guests which included at least 21 vehicles, nearly half of them being our classic Model-Ts and A's belonging to the Conlons, Francois, Graton, Gumbinger, McAlpin, Rohde, Allen & Hartzler. Dave Veres even arrived in a 1966 Ford Fairlane and the Harts in a newer Ford Mustang....my apologies if I missed anyone. It was a beautiful sunny day and not too cold to gather outside in a huge circle, social distancing 6 feet apart. It was difficult at times to recognize everyone with the masks and sunglasses on, but we managed and had a good time catching up with each other. Once the socialization quieted down, President Sandy Hart called the meeting to order at 2:25 by thanking everyone for coming and participating in this event. Items on the agenda included:

<u>Nomination of Treasurer</u> for the 2021-2022 years. Dave Veres has been our treasurer for the past many, many years and he was nominated again and agreed to continue in that capacity. Nomination seconded and unanimously approved.

<u>Nomination of Vice President</u> for the 2021-2022 years. Tom Hoverson was nominated by Dave McAlpin. Nomination seconded and also unanimously approved.

Every year at Christmas our Club chooses a <u>Charity</u> and this year there were 3 different ones to choose from. By a raise of hands, the Charity chosen was *Save The Family*, a recommendation by Jan Peterson. This organization assists people in Mesa by helping them find jobs, feeding and clothing them, etc. It was suggested that a donation of \$300.00 be given to them which was seconded and approved. The Club also made a donation of \$200 to the Model-T Ford Museum during the Wayne County Foundation Match program giving the Museum \$400 total on behalf of EVMTFC.

The majority of the meeting was discussing new storage for the <u>Chuckwagon owned by EVMTFC</u>. In years past, different Club members have stored the wagon at their own homes but the current home for it is no longer available due to lack of space since it needs to be stored inside a building. There were several new options that were suggested: (a) Secure a storage unit at \$59.00/mo. which would also be large enough to store other Club assets such as tables, pop up tents, extra supplies, memorabilia, etc. (b) Sell the Chuckwagon with proceeds going back to the Club, (c) Sell the Chuckwagon with proceeds going to the 5 original members that donated parts and who built the wagon, (d) The Linney's offered to move things around in their garage to store just the wagon for \$25/mo. but did not have room for the Club's other assets, and (e) Donate the Chuckwagon to the Model-T Museum in Indiana or perhaps a museum in our area

We quickly decided that if the Club chose (b) to sell The Chuckwagon, we would no doubt regret it in the future since it is unique and one of a kind, even though at the present time we only use it 2 or 3 times a year. Regarding item (e), Keith Gumbinger as treasurer of MTFCA said the Museum recently raised \$52,000 so have met their goal for this year. Item (c) was not a possibility since the Club was the owner of the wagon and not any individual members. It was decided that Item (d) of Linney's offer would not work since the Club's assets would still be scattered at different people's home, so that left item (a), Paying for storage not to exceed \$900 a year. It was voted, seconded and approved that Sandy secure a storage unit. There is enough money in the treasury and also suggestions were made how to raise additional funds which will be discussed at future meetings.

<u>Awards Presentation</u> - Sandy awarded plaques to outgoing officers from the 2019-2020 years. One to Dave Veres, also our incoming Treasurer as well. One to our outgoing Vice President, Dale Guenther, who he hopes will be spending the next year travelling because Marcia finally retired. One to Ed Stolinski (who wasn't able to attend) as the outgoing holder of the Bob Wildman award, and finally - the Big One, the trophy award to the new recipient of the Bob Wildman award, JEFF HENRY, as follows:

Jeff Henry is always willing to lend a helping hand when anyone needs one. He does an amazing job of keeping our website updated to the point in some cases it is updated even before an event is over. He does not get distracted by the activities going on around him and is able to capture all the significant activities on video. To illustrate Jeff's willingness to help, on one occasion he and Dave Veres went out to Austin Graton's home on their own initiative to help him with construction of the art studio he was building for Lynn. They stayed and worked all day. In a Club like ours, it is only through volunteer efforts from members like Jeff, that things get done. He is truly a deserving member.

Dave collected the \$20 yearly dues for 2021 from most of the members who attended. For those that were unable to attend, please mail your dues to - Dave Veres, 2531 E LaJolla Dr., Tempe, AZ 85282. Here's a recipe I thought you might need for the next newsletter: I found it in a 1938 'The American Woman's Cook Book'

2 tablespoons gelatin 1/4 cup cold water 3/4 cup boiling water 2 cups sugar 1/8 teaspoon salt 1 teaspoon vanilla Confectioners sugar

Soak the gelatin in the cold water until it has taken up all the water. Boil the sugar and water to the soft-ball stage (238 degrees). Add vanilla and salt to gelatin. Pour the syrup slowly over the gelatin, beating constantly with a whisk until cool and thick. Butter a shallow pan slightly and dust with confectioners sugar. Turn the above mixture into the pan and smooth the top evenly. Dust with confectioners sugar. Let it stand over night. In the morning cut it into small squares and roll in confectioners sugar.




